## **IP Enforcement at Trade Shows**

### • Enforcement Routes:

- Judicial proceedings
- Trade show ADR mechanisms
- Other routes (e.g., customs measures)

### • Challenges:

- Speed (ex parte measures)
- Expertise



### **Examples of Courts with Accommodation Practices**

- Landgericht Braunschweig, Patentstreitkammer
  - Bereitschaftsdienst for Hannover (since 1967)
- Landegricht München I (Munich)
- Commercial Courts of Barcelona
  - Protocolo de Actuación Rápida (since 2015)
- Protective letters (Schutzschriften)
  - E.g., Germany, Switzerland, the Netherlands, Spain, France

### **Examples of Trade Show ADR Mechanisms I**

#### **Baselworld IP Dispute Resolution Panel**

- Basel, Switzerland, since 1985
- A mandatory mechanism for exhibitors
- Design, trademark or other indication of source, copyright, and unfair competition under Swiss law (no patents starting 2016)
- A panel of six voting members, including three Swiss lawyers and two industry experts (status in 2017)
- Immediate removal from the trade show, prohibition of sales at the trade show, closure of the exhibition booth, exclusion from future shows
- In 1985 2016, a total of 873 complaints (9 50 per year)

### **Examples of Trade Show ADR Mechanisms II**

#### Palexpo/WIPO Fast-Track IP Dispute Resolution Procedure

- Geneva, Switzerland, since 2015
- An optional mechanism
- Design, trademark, copyright, and unfair competition under Swiss law (no patents)
- An Expert Panel (a one-member Panel) appointed for each case from a WIPO list of experts (WIPO Arbitration and Mediation Center)
- A provisional removal, a cease and desist declaration, a closure of a stand, a removal of item(s), a stop to the sales of item(s), performance of other legal obligations
- As of August 2017, three cases filed, one case decided
