The William S. ## A Community of Scholars

In the short history of the law school, the faculty has written more than 100 books, more than 110 book chapters, and more than 600 law review articles. The faculty is engaged in scholarly societies and conferences meeting around the world, and often have leadership roles. The law school hosts visiting scholars (from the United States and foreign countries), conferences and colloquia to enrich the intellectual life of the community. 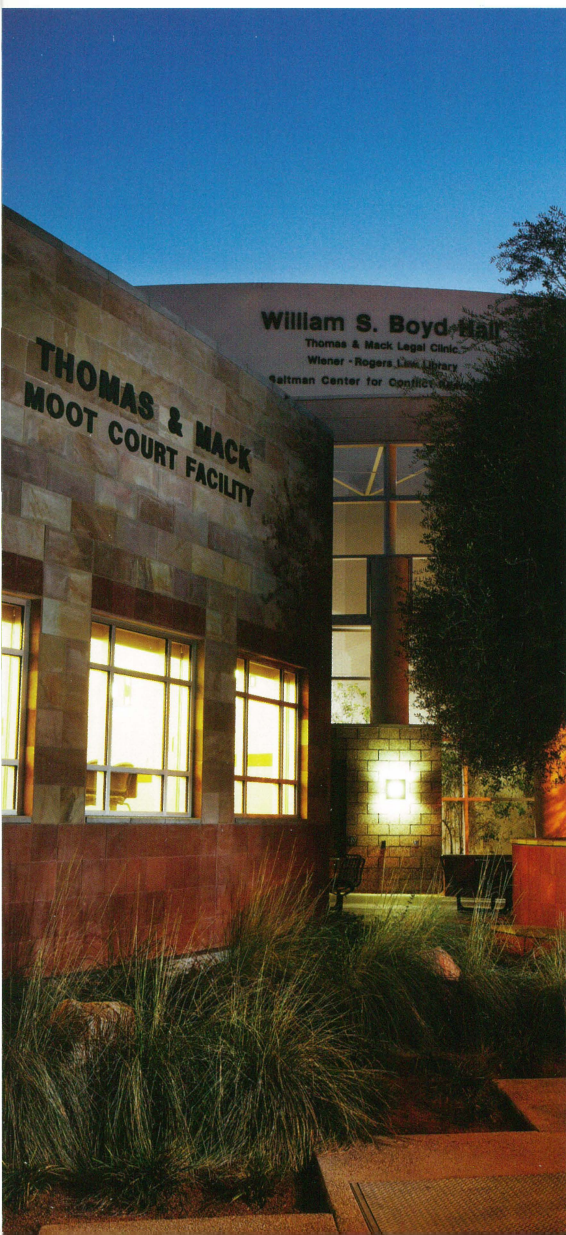

Her current research focuses on the linkages between anti-subordination movements, and how legal institutions and cultures impact access to justice.
